



2026 Innisfil Heritage Property Awards

The Town of Innisfil and the Innisfil Heritage Advisory Committee wish to recognize property owners in our community who have demonstrated their efforts to preserve and enhance the heritage attributes of their properties.

Award Categories

Residential Buildings	For preservation, restoration, or adaptive reuse of residential properties in Innisfil
Commercial Buildings (e.g., Offices, stores, restaurants)	For preservation, restoration, or adaptive reuse of commercial properties in Innisfil
Institutional Buildings (e.g., churches, schools or public facilities)	For preservation, restoration, or adaptive reuse of institutional buildings in Innisfil
Landscaping	For the appropriateness of landscaping treatment to the period of a building. For new plantings, selection and use that complement the heritage attributes and qualities of the site.

Who is Eligible?

Properties must be located in the Town of Innisfil and be sensitive to one or all of the following:

- The property or buildings are well-maintained.
- Are sensitive to the heritage features of the property, especially if the property has been restored, rehabilitated or adaptively re-used.
- Enhances the streetscape; or,
- Assists in revitalizing the community through heritage conservation.
- **A property does not need to be recognized as a heritage property or included on the Town of Innisfil's Heritage Register to be eligible to apply.**
